A local grassroots movement started around the idea that community leaders should be chosen in open non-partisan elections and free to focus on issues that impact Berwyn. The old concept of electing local leaders through the partisan primary system forces voters to declare a national political party and handcuffs candidates into holding the party line when regional members of the same political party may not be support-

ing Berwyn's best interests. The idea of putting local concerns first drove the non-partisan ballot initiative in March 2024 to an over 75% approval rating by Berwyn voters. Due to this initiative, anyone can vote for a candidate for local municipal offices in February 2025 without declaring a political party and those elected must get a majority of the entire popular vote as independent candidates. future leaders from various local political projects have formed a collective think tank committed to shared governance and setting individual agenda's aside to put Berwyn's interests first. The representatives of this group are not a political party, but instead a movement that calls themselves Berwyn Strong. This group includes former members of different political organizations and other non-partisan community leaders

who realize that constructive debate is necessary, and no single group has all the answers. Berwyn Strong is a concept created by all those who have embraced the idea and have pledged to forego any personal or national political agendas to keep the community as the top priority. They all believe that the path forward is setting up checks and balances to ensure that the focus of local government is always on the best interest of Berwyn.


